**TERMS AND CONDITIONS**

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entrants are only open to Australian residents aged 18 years or over.
3. Employees (and their immediate families) of the Promoters, tenants and their employees of the promoter, and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1<sup>st</sup> cousin.
4. The 'Promotional Period' begins at 9am on Monday 2 March and closes at 5pm on Sunday 15 March 2026.
5. To be eligible, individuals must complete the following steps during the Promotional Period:
  - Customers are required to spend \$100 at any retailer in centre in one day. Spend of \$100 can be at multiple stores and receipts can be accumulated.
  - Customers must scan a QR code at one of the touch points in centre or on the Casey Central website, fill in their details, and upload their receipt/s to go into the draw to win.
  - Customers can, if having issues scanning the QR Code, email [marketing@caseycentral.com.au](mailto:marketing@caseycentral.com.au) with their contact details and a copy of the receipt to be entered into the draw.
  - Excludes spend on, partial lay-bys, gift voucher/card purchases, postal services, prescription purchases, interest free purchase payments, eftpos and ATM receipts, purchase of tobacco, alcohol, fuel, Lotto or TAB, bill payments such as the payment of credit card bills, bank transactions, bank fees and charges and service bills (such as gas, electricity, rates, doctors and phone bills) are ineligible to receive a Gift Card.
  - Click and collect purchases qualify with a valid receipt.
  - Limit of one entry per person per day and receipts cannot be reused. Customers can enter multiple times during the promotion period when shopping in centre on different days.

The Promoters reserve the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoters have reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoters discretion. Failure by the Promoters to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoters' legal rights to recover damages or other compensation from such an offender are reserved.

6. Incomplete or indecipherable entries will be deemed invalid.
7. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.

9. Winners will be notified within three (3) business days of the draw via email and prize must be collected from the Centre Management Office at Casey Central Shopping Centre during business hours with a valid form of ID.
10. The Promoter may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn.
11. The Promoter's decision is final, and no correspondence will be entered into.
12. Promotion prize pool:

13. Any ancillary costs associated with redeeming any prizes are not included. Any unused balance of prizes will not be awarded as cash. Redemption of prizes is subject to any terms and conditions of the issuer including those specified on the prize.
